### **Privacy Statement**

(HITA-SECURITIES Inc. in English) is aware that the security of your personal data is crucial when using our website, so we take the protection of your personal data very seriously. Therefore, we want you to know when we store certain data and how we use it. This Privacy Statement aims to inform you about our security measures.

# **Data Collection**

You can use our website <u>www.hita.hr</u> without disclosing your personal information. You are not required to provide personal data as a condition of using the website unless it is necessary to provide you with a service or enable the use of our services at your request. When you use our website, your browser will transfer certain data to our web server for technical reasons, and we may store this data for various security and functional reasons. Such data may include the following: the name of your Internet service provider, IP address, date and time of access, time zone difference relative to Greenwich Mean Time (GMT), content of the request (specific page), access status/HTTP status code, amount of data transferred, the website that requires access, browser, language settings, browser version, operating system and screen resolution, and the website through which you connected to our site, as well as websites you visited from our site. This data could potentially lead to your identification, but we do not use it for this purpose. Occasionally, we use this data for statistical purposes while ensuring each user remains anonymous, so identification is not possible. Furthermore, to protect our legitimate interests, we store such data for a limited period to begin tracking personal data in cases of or attempts at unauthorized access to our servers (Article 6(1)(f) of the General Data Protection Regulation).

When we entrust data processing tasks to third parties, either to provide a product or service you requested or for other purposes to which you consented, we ensure that the third party is registered to perform such activities, offers sufficient guarantees for data protection and confidentiality, and we rely on technical and organizational measures to ensure compliance with data protection regulations.

To access <u>https://etrade.hita.hr/</u>, it is necessary to conclude a Brokerage Agreement, and we may identify you during your usage. Similarly, your browser will transfer certain data to our web server, as with <u>www.hita.hr</u>.

#### Collection and Processing of Personal Data

We collect personal data only when you voluntarily provide it to us, such as through registration, form completion, email, inquiries, or requests related to our products or services, or in similar situations where you chose to share data with us. Our company, along with our data processors and servers acting on our behalf, remains responsible for the database and its contents. We will not share your personal data with third parties (either directly or through agents) unless there is a legal basis for doing so. We will maintain control and responsibility for the use of any personal data you have shared with us.

# Purpose of Use

The data we collect will be used solely to provide our services or for other purposes for which you have given your consent, except where otherwise required by law.

#### Right to Access and Correction

You have the right to access all your personal data stored by us and to correct, supplement, or delete it if it is incomplete, inaccurate, or outdated. To do so, simply send an email to our address or contact our Data Protection Officer at the address provided below.

# Right to Withdraw Consent

You have the right to withdraw your consent for personal data processing at any time and request the cessation of further processing, except in cases where data is processed for statistical purposes and your personal data no longer enables identification. We retain personal data if it is necessary to provide the requested service or service for which you have given consent, unless otherwise prescribed by law (e.g., per the regulator's instructions, Tax Authority, in relation to ongoing legal proceedings, etc.).
